The Government of Sindh has received credit through EAD, Govt. of Pakistan from the International Development Association and intends to apply part of the proceeds of this credit to payments under the contract for **Karachi Neighborhood Improvement Project (KNIP)** to perform the consulting services.
2. The required consulting services namely DESIGN, CONSTRUCTION SUPERVISION & CONTRACT MANAGEMENT FOR CIVIL WORKS - PHASE 2 (the Services) under the project, comprises of 2 stages, will cover but not limited to the following scope:
  - a. Preparation for Base map, and Preliminary Conceptual Designs;
  - b. Detailed Engineering/Urban Designs;
  - c. Environmental and Social Impact Assessment;
  - d. Construction Supervision and Contract Management;
  - e. Planning, Designing, Construction and Operation related Environmental and Social Safeguard Management, RAP Sub Project wise Documents;

2.	<b>General experience</b> of providing services in Infrastructure Development under urban setting. Five (05) development projects during last Ten (10) years are required to be completed successfully. Mention the projects completed in Nov 2009 onwards.
3.	<b>Relevant experience of Design &amp; Construction Supervision</b> of successful completing at least three (03) similar projects such as municipal streets, urban roads, Parks, Parking Plaza's and public space improvement during last ten (10) years (contracts completed in Nov 2009 onwards). The contract value of each contracts should be Rs. 200 million or more.
